Entour Venue Safety Precautions

- Be sure to save the packing carton in the unlikely event the unit may have to be returned for service
- Do not spill water or other liquids into or on to your fazer. Be sure that all the fog fluid is kept inside the fluid reservoir
- Be sure that the local power outlet match that or the required voltage for your fog machine
- Do not remove the top cover under any conditions. There are no user serviceable parts inside
- Disconnect the unit's main power when left unused for long periods of time
- Never connect this unit to a dimmer pack
- · Do not attempt to operate this unit, if it becomes damaged in anyway
- · Never operate this unit when it's cover is removed
- To reduce the risk of electrical shock or fire, do not expose this unit rain or moisture
- Do not attempt to operate this unit if the power cord has been frayed or broken. Do not attempt to remove or break off the ground prong from the electrical cord. This prong is used to reduce the risk of electrical shock and fire in case of an internal short

Power Supply: Before plugging your unit in, be sure the source voltage in your area matches the required voltage for your ADJ Entour Venue. The ADJ Entour Venue is available in a 120v and 240v version. Because line voltage may vary from venue to venue, you should be sure your unit voltage matches the wall outlet voltage before attempting to operate you fixture.

DMX-512: DMX is short for Digital Multiplex. This is a universal protocol used as a form of communication between intelligent fixtures and controllers. A DMX controller sends DMX data instructions from the controller to the fixture. DMX data is sent as serial data that travels from fixture to fixture via the DATA "IN" and DATA "OUT" XLR terminals located on all DMX fixtures (most controllers only have a DATA "OUT" terminal).

DMX Linking: DMX is a language allowing all makes and models of different manufactures to be linked together and operate from a single controller, as long as all fixtures and the controller are DMX compliant. To ensure proper DMX data transmission, when using several DMX fixtures try to use the shortest cable path possible. The order in which fixtures are connected in a DMX line does not influence the DMX addressing. For example; a fixture assigned a DMX address of 1 may be placed anywhere in a DMX line, at the beginning, at the end, or anywhere in the middle. When a fixture is assigned a DMX address of 1, the DMX controller knows to send DATA assigned to address 1 to that unit, no matter where it is located in the DMX chain.

Data Cable (DMX Cable) Requirements (For DMX Operation): The Entour Venue can be controlled via DMX-512 protocol. The Entour Venue has 3 DMX channel modes, 1 channel, 2 channel, and 4 chan-

nel. The DMX address is set on the back panel. Your unit and your DMX controller require a standard 3-pin XLR connector for data input and data output (Figure 1). We recommend Accu-Cable DMX cables. If you are making your own cables, be sure to use standard 110-120 Ohm shielded cable (This cable may be purchased at almost all pro lighting stores). Your cables should be made with a male and female XLR connector on either end of the cable. Also remember that DMX cable must be daisy chained and cannot be split.

Entour Venue DMX Information

Notice: Be sure to follow figures two and three when making your own cables. Do not use the ground lug on the XLR connector. Do not connect the cable's shield conductor to the ground lug or allow the shield conductor to come in contact with the XLR's outer casing. Grounding the shield could cause a short circuit and erratic behavior.



Special Note: Line Termination. When longer runs of cable are used, you may need to use a terminator on the last unit to avoid erratic behavior. A terminator is a 110-120 ohm 1/4 watt resistor which is connected between pins 2 and 3 of a male XLR connector (DATA + and DATA -). This unit is inserted in the female XLR connector of the last unit in your daisy chain to terminate the line. Using a cable terminator (ADJ part number Z-DMX/T) will decrease the possibilities of erratic behavior.

Termination reduces signal errors and Iermination reduces signal errors and avoids signal transmission problems and interference. It is always advisable to connect a DMX terminal, (Resistance 120 Ohm 1/4 W) between PIN 2 (DMX-) and PIN 3 (DMX +) of the last fixture.

5-Pin XLR DMX Connectors. Some manufactures use 5-pin DMX-512 data cables for DATA transmission in place of 3-pin. 5-pin DMX fixtures may be implemented in a 3-pin DMX line. When inserting standard 5-pin data cables in to a 3-pin line a cable adaptor must be used. these adaptors are readily available at most electric stores. The chart below details a proper cable conversion.





Entour Venue General Set-Up

- 1. Open the shipping carton and carefully remove the unit from the shipping carton.
- 2. Be sure to remove all the packing material especially around the nozzle.
- 3. Set the fog machine on a flat dry surfaceand fill the fog fluid reservoir with American DJ brand fog juice. Place the feeder tube with the filter deep inside the reservoir and tighten the cap.
- 4. Plug the unit in to a matching power supply and the unit will begin to heat up. Wait about 45 seconds for the fogger to reach normal operating temperature.
- 5. Follow the operating instructions on the next pages for proper operation.

Entour Venue Start Up

START UP:

1. Connect the provided PowerCon cable to the fog machine input. Then plug the power cord into a matching power source. There is no ON/OFF switch.

2. Primary power is now "On". Version: 1.0

3. 2 Seconds after power is applied the unit Warming will begin to warm up. Up.....

4. After the unit has warmed up, the last function that was operating before power was shut off will be displayed again. Exam**ple:** If the Timer function was active that will be displayed.

TIMER OPERATION:

1. DUR. xxx INT. xxx

Press the TIMER button to enter the fog timer operation.

- 2. Press the FUNCTION button to enter the timer settings menu.
- 3. --> Dura xxx Intv xxx

Use the UP or DOWN buttons to adjust duration (output) time, 3s-250s.

- 4. Press the FUNCTION button to switch to interval adjustment.
- 5. Dura xxx
 --> Intv xxx

Use the UP or DOWN buttons to adjust interval (pause) time, 5s-250s.

6. DUR. xxx INT. xxx

Press the TIMER button again to activate the timer function. Press the TIMER button again to deactivate the timer function.

7. (Stop) Cleaning

When you stop Timer operation the display will read (Stop) Cleaning. This will take about 15 seconds.

8. DMX set Addr- xxx

After cleaning is done, the DMX setting display will show.

NOTE: To keep your timer settings the same when shutting down, press timer, the display should read "(Stop) Cleaning". The machine is now emptying all the fluids from the pipes this will take from 15-30 seconds. After this process is finished, you can then shutdown the machine. When you turn the machine on again and press timer, your last settings before shutting down should still be there. Do not shutdown the machine without running the cleaning process.

Entour Venue Operation

CONTINUOUS FOGGING:

1. --> Vol xxx Fan xxx

Press the HOLD button to start continuous fogging. **NOTE:** Fogging will start right away.

2. --> Vol xxx Fan xxx

Use the UP or DOWN buttons to adjust output volume, 5%-100%.

- 3. Press the FUNCTION button to switch to Fan adjustment.
- 4. Vol xxx
 --> Fan xxx

Use the UP or DOWN buttons to adjust Fan speed, 5%-100%.

- 5. Press the HOLD button again to stop continuous fogging.
- 6. (Stop)

When you stop continuous fogging the display will read (Stop) Cleaning. This will take about 15 seconds.

7. DMX set Addr- xxx

After cleaning is done, the DMX setting display will show.

MANUAL FOGGING:

1. Manual V100 F100 Press the MANUAL button (without releasing). The machine will output at maximum level and maximum fan speed. Release the button to stop fogging.

2. (Stop) Cleaning

When you stop fogging the display will read (Stop) Cleaning. This will take about 15 seconds.

3. DMX set Addr- xxx

After cleaning is done, the DMX setting display will show.

NOTE: If running manual mode and you would like to keep your timer settings, press timer, then press it again. The display should read "(Stop) Cleaning". The machine is now emptying all the fluids from the pipes this will take from 15-30 seconds. After this process is finished, you can then shutdown the machine. When you turn the machine on again and press timer, your last settings before shutting down should still be there. Do not shutdown the machine without running the cleaning process.

Entour Venue DMX Mode

DMX Mode:

The Entour Venue has 3 DMX channel modes; 1 channel mode, 2 channel mode, and 4 channel mode. See page 13 for the DMX traits.

- 1. This function will allow you to control each individual fixture's traits with a standard DMX 512 controller.
- 2. When the display is showing the DMX setting screen, use the UP or DOWN buttons to find your desired DMX address.

DMX set Addr- xxx

- To run your fixture in DMX mode you must FIRST plug in the fixture via the XLR connections to any standard DMX controller.
- Once you have the controller connected to the unit you will be able to select your desired DMX channel mode. Press the FUNCTION button to cycle through the DMX channel modes.

1ch.Axxx VxxxFxxx 2ch.Axxx VxxxFxxx

5. When 4 channel mode is selected, after about 5 seconds the screen will change to the display shown below.





Entour Venue Maintenance

The fluid cannot get dirty. Always make sure the cap is clean and the fog fluid line. Periodically nozzle maybe come clogged by impurities contact ADJ customer service for a replacement nozzle.




With prolonged use, the flight case side air filter can accumulate dust. Perodically remove the flight case side cover and remove the air filter to clean. After cleaning, be sure to dry the air filter, an reinstall the filter and cover. If you would like to replace the air filter, contact ADJ customer service.

With prolonged use, the the sponge inside the vent may accumulate oil. Periodically clean the sponge or replace with a new one. If you would like to replace the sponge, contact ADJ customer service.



When storing your fog machine be sure to store it in a cool area. Cover the machine so that dust does not build up on the unit. When storing the machine for long periods of time, it is highly advised to at least run the machine every 3-4 months. Long periods of inactivity can severly shorten the life of your machine. Only run water based fog juice through your machine. Never run plain water, vinegar, or any other liquid solution through your machine. Running anything other then water based fog juice will severly damage your machine.

Entour Venue Warranty Registration

The Entour Venue fog machine carries a one year (365 days) limited warranty. Please fill out the enclosed warranty card to validate your purchase. All returned service items whether under warranty or not, must be freight pre-paid and accompany a return authorization (R.A.) number. The R.A. number must be clearly written on the outside of the return package. A brief description of the problem as well as the R.A. number must also be written down on a piece of paper and included in the shipping container. If the unit is under warranty, you must provide a copy of your proof of purchase invoice. You may obtain a R.A. number by contacting customer support at (800) 322-6337.

If you experience low fog output, pump noise, or no fog output at all, disconnect and discontinue use immediately. Do not attempt to continue pushing the remote control's activation button as this may damage the fog machine. Check the fluid level, the breaker, and be sure the wall outlet is sending power. If all of the above appears to be okay, and the unit fails to operate correctly, the unit will require service. Please contact ADJ Products, LLC.
